Tariff Filing

Non-Conforming Service Agreement Filing (Docket No. RP23-369-000)

On February 10, 2023, the Commission approved Northwest's January 23, 2023 Filing to (1) remove the previously filed Citadel Energy Marketing ("Citadel") service agreement that contained non-conforming provisions (Agreement No. 141322) from the list of non-conforming service agreements included in Northwest's Tariff, (2) remove the service agreement from Northwest's Original Tariff and (3) include minor corrections. The effective date of the tariff records was February 23, 2023.

Report of Federal Income Tax Refunds (Docket No. RP22-1155-000)

On February 24, 2023, the Commission accepted Northwest's January 31, 2023 filing of a report of refunds detailing the refunds made in accordance with Article VI of the 2022 Stipulation and Settlement Agreement to satisfy Northwest's requirement to return regulatory liability recorded as a result of the corporate income tax reductions during the settlement term of the 2017 settlement. The refund covers the period January 1, 2018 to December 31, 2022.

Non-Conforming Service Agreement Filing (Docket No. RP23-463-000)

On February 24, 2023, Northwest filed a restatement of a non-conforming service agreement (Agreement No. 137605) between Northwest and IGI Resources, Inc. ("IGI") for inclusion in Northwest's Original Tariff; and (2) update its list of non-conforming service agreements provided in the Tariff. On February 17, 2023, Northwest and IGI restated this Service Agreement to extend its term through October 31, 2030. The proposed effective date of the tariff record is March 27, 2023.

2023 North Seattle Lateral Upgrade and South Seattle Annual Charges Update Filing (RP23-483-000)

On February 28, 2023, Northwest filed the annual incremental facility charges for the South Seattle Delivery Lateral Expansion Project and North Seattle Lateral Upgrade Project in compliance with the Commission's orders issued in Docket No. CP12-471 and Docket No. CP17-441. The proposed effective date of the tariff records is April 1, 2023.

Semi-Annual and Annual Fuel Reimbursement Filing (Docket No. RP23-479-00)

On February 28, 2023, Northwest filed its semi-annual fuel filing and annual fuel reimbursement filing to place into effect new factors on April 1, 2023. Northwest changed the following factors: (1) no change to the current 1.06% in the transportation services factor; (2) increase from 0.32% to 0.49% in the underground storage services factor; (3) an increase to 0.23% to 2.08% in the LNG liquefaction service factor; and (4) no change to the Liquification charge.
