# US Census Bureau Update – AES Reporting Summary of Filing Requirements

- > 15 CFR part 30 Enables the Census Bureau to require information on all exports, either through the filing of EEI (Electronic Export Information) via AES (Automated Export System) or advising that the filing in AES is exempt or excluded
- > USPPI's (United States Principal Party in Interest, or shippers on NWP) must provide the carrier (NWP) either the proof of filing citation or the exemption or exclusion legend
- Northwest must annotate CBP (U.S. Customs of Border Protection) documentation and provide it to them on a monthly basis



#### **General Requirements 15 CFR part 30**

- > 30.2(a)(1) EEI must be filed by USPPI through AES for all exports of physical goods
- > Subpart D Exemptions from EEI filing in AES
  - -30.36 Shipments to Canada
  - -30.37 In-transit movements
    - (c) US-Canada-US
    - (d) Canada-US-Canada
    - (e) in-bond through US and exported
- > 30.2(a)(1)(iv)
  - Supersedes Subpart D exemptions where goods under "export license" = AES reporting



# US Pipeline Exports under Export License/DOE Authorization

#### > USPPI must:

- File EEI in AES and obtain ITN (Internal Transaction Number) or provide NWP with exemption legend by end of 4<sup>th</sup> calendar day following month of export
- Provide NWP with ITN by end of 4<sup>th</sup> calendar day
- > NWP to provide applicable CBP port with proof of filing (exempt & non-exempt) citation within same 4 calendar day period

#### Filing Conventions for Natural Gas

#### **United States Principal Party in Interest (USPPI)**

As defined in 15 CFR, Part 30

"The person or legal entity in the United States that receives the primary benefit, monetary or otherwise, from the export transaction. Generally, that person or entity is the U.S. seller, manufacturer, or order party, or the foreign entity while in the United States when purchasing or obtaining the goods for export."



### Filing Conventions for Natural Gas (cont)

#### > USPPI data given:

- Address Line 1 is the name of the US pipeline that carries the natural gas into Canada (Northwest Pipeline LLC)
- City, State and Postal Code are the city, state and zip code of the US city nearest the border crossing of the pipeline (Sumas, Washington 98295)
- State of Origin is where the natural gas leaves the US (Sumas & SIPI delivery points are in Washington)
- Port of Export is the nearest CBP port to the actual border crossing location that is valid for a "fixed" method of transportation (3009 is Sumas, 3401 is Pembina, ND)
  - List of fixed ports are in Appendix D of the AES Trade Interface Requirements (AESTIR)



### Filing Conventions for Natural Gas (cont)

- > Two options for Date of Export
  - File shipments during the month and report the date of export on daily basis
  - Shipments made throughout the month can be reported as one shipment on the last day of the month if they have the same:
    - USPPI
    - Ultimate Consignee
    - Departure Month
    - Pipeline
    - Foreign Trade Zone (not applicable for natural gas)
- > Ultimate Consignee
  - If the ultimate consignee is known, report the foreign party that receives the gas, OR if not known, the name and address of the hub closest to the border crossing may be reported



### Filing Conventions for Natural Gas (cont)

- > Unit of Quantity
  - Unit of Quantity for natural gas is cubic meters
  - The formula for cubic meters is
    - 1 dekatherm = 1,000 cubic feet
    - (0.02832784 factor to convert cubic feet to cubic meters) 1,000 cubic feet x .02832784 = 28.32784 cubic meters
    - Therefore, 1 dekatherm = 28.32784 cubic meters
- > Valuation of gas
  - Shipper to use their own valuation dollar amount. Ensure the same dollar amount is used on the AES and reported to NWP

#### **NWP Carrier Reporting**

- > After monthly pipeline reconciliation finalized (by end of 4<sup>th</sup> calendar day), NWP provides to US Customs of Border Protection Outbound Programs Team
  - Monthly report of deliveries of natural gas in Canada summarized by shipper/consignee/batch
  - ITN's / exemptions received by NWP
- > No requirements for NWP to enforce shipper compliance
  - NWP will be compliant in reporting data
