Tariff Filings**2025 Summer Fuel Filing (Docket No. RP25-647-000)**

On March 20, 2025, the Commission approved Northwest's February 28, 2025, semi-annual fuel filing and annual fuel reimbursement filing. Northwest changed the following factors: (1) increase from 1.05% to 1.39% in the transportation services factor; (2) increase from 0.38% to 0.39% in the underground storage services factor; (3) increase from 0.56% to 1.31% in the LNG liquefaction storage service factor; and (4) increase from 0.31% to 1.56% in the LNG vaporization storage service charge. The effective date of the new factors is April 1, 2025.

North Seattle and South Seattle Annual Charge Update Filing 2025 (Docket No. RP25-618-000)

On March 20, 2025, the Commission approved Northwest's February 27, 2025, filing of the annual incremental facility charges for the South Seattle Delivery Lateral Expansion Project and North Seattle Lateral Upgrade Project in compliance with the Commission's orders issued in Docket No. CP12-471 and Docket No. CP17-441. The effective date of the tariff records is April 1, 2025.

Operational Sales and Purchases Report (Docket No. RP25-578-000)

On February 20, 2025, Northwest filed its annual report detailing the operational sales and purchases of natural gas made for the twelve-month period ending December 31, 2024.

Annual Modernization and Emissions Reduction Program Cost Recovery Mechanism ("CRM") (Docket No. RP25-562-000)

On March 13, 2025, the Commission approved Northwest's February 12, 2025, Cost Recovery Mechanism ("CRM") surcharge filing in compliance with Section 30.2(a) of the General Terms and Conditions (GT&C) of its FERC Gas Tariff. The CRM surcharge established by this filing is \$0.02256, effective April 1, 2025 through March 31, 2026.

NASEB 4.0 Compliance Filing (Docket No. RP25-425)

On January 30, 2025, Northwest filed proposed tariff records to incorporate Version 4.0 of the NASEB Wholesale Gas Quadrant's ("WGQ") consensus standards. The filing is in compliance with Order No. 587-AA, issued November 22, 2024, in Docket RM96-1-043, and the effective date for the tariff records filing is August 1, 2025.

Certificates

Kelso-Beaver Reliability

On February 27, 2025, Northwest filed an application pursuant to section 7(c) of the Natural Gas Act and Part 157 of the Commission's regulations for its proposed Kelso-Beaver Reliability Project ("Project"), an acquisition of the existing Kelso-Beaver Pipeline ("KB Pipeline") and its meter stations and appurtenant facilities will become a lateral extension of Northwest's existing interstate natural gas transmission system. The Project also includes expanding the existing KB Pipeline and making it bi-directional in order to utilize the North Mist Storage facility. The Project is targeted to be placed into service by November 2028.
